6. If my/our tender is selected as the most advantageous one, I/we agree to sign the lease agreement reading as specified in Appendix no. 2 to the Tender Notice at the place and time specified by the Lessor.
7. In order to secure the payment of rent and contractual penalties set forth in the draft Lease Agreement, I/we declare voluntary submission to enforcement pursuant to Article 777 of the Code of Civil Procedure in accordance with the provisions of the draft Lease Agreement
8. I/we declare that:
 - 1) I/we have have read the subject, terms and conditions of the tender and I/we accept them without reservations,
 - 2) I/we have got familiar with the Lessee's obligations specified in the Tender Notice and the ones implying from the draft Lease Agreement and I/we accept them without reservations, in particular as regards the necessity to:
 - a) make the Subject of Lease available, free of charge, to the Polish Football Association (hereinafter referred to as PZPN), in accordance with the contents of Section VII par. 4(1) of the Tender Notice
 - b) sublet or sublease, on equal and non-discriminatory terms to be determined by a Resolution of Szczecin City Council, the Subject of Lease to football clubs and associations whose activities involve training children or youth in football, and to local football clubs taking part in competitions at various levels of football leagues,
 - c) with regard to the necessity to make the Subject of Lease available to Szczecin City Municipality or an entity designated by it in accordance with the provisions of Section VII par. 7,8, 9 of the Tender Notice,
 - d) with regard to the necessity to the need to ensure to the locker room building and the car park located on the Subject of Lease and with regard to necessity to sublease the above mentioned locker room building, in accordance with the provisions of Section VII par. 1(9) of the Tender Notice,
 - 3) I/we have become familiar with the limitations related to the Investment carried out by the Lessor and accept them without reservations, and that I/we will not make any claims against the Lessor, including in particular claims for a reduction of the rent due to the impeded use of the subject of lease, as well as claims for damages due to partial loss or failure to achieve the planned profit in connection with the limited possibility for the Lessee to use the subject of lease.
9. I/we declare that I/we meet the conditions for participation in the tender set forth in Section IX of the Tender Notice.
